Hire Agreement Terms and Conditions

1. Definitions

In these conditions:

- I. “Interactive” is Interactive Electrical Systems Pty Ltd ABN 14 659 024 398 trading as Interactive Electrical Systems
- II. The “Hirer” refers to the person, company or corporation hiring the plant from Interactive.
- III. The “Plant” means all equipment, including all accessories and parts supplied by the hirer

2. Contract

- I. Hire charge commences from the time the Plant leaves Interactives possession at the Hirer’s request, not from the time the plant is used/installed, (inclusive of weekends and Public Holidays).
- II. All electrical equipment hired from Interactive is tested & tagged before leaving our premises and are valid for 3 months from the delivery date. It is the Hirer’s responsibility to ensure tagging is kept up to date for the duration of the hire period.
- III. The Hirer shall pay Interactive the full amount of the agreed contracted rental rate for the initial hire period, even if the contract is terminated prior to the termination date.
- IV. The rental period will be calculated from the date of delivery and/or installation of the Plant hired, or the Hirer collects the Plant from Interactive and will continue until the termination of the hire in accordance with these conditions.
- V. On conclusion of the initial hire period, the rental will automatically continue daily at the agreed daily charge until the Hirer has notified Interactive that they desire to terminate the hire agreement and the is ready for collection or will be returned to Interactive by the Hirer.
- VI. The Hirer may terminate this agreement at any time by contacting Interactive. Should this be after the initial hire contract date, hire charges shall cease from this notification, however, notice of 5 working days must be provided to allow Interactive to collect the Plant from site. Clear access to the Plant hired must be provided to Interactive when Plant collection is arranged, should Plant not be accessible additional charges will be made for waiting time.

3. Responsibilities of Hirer

The Hirer shall:

- I. Be responsible for the suitability of the Plant Hired for the purpose required.
- II. Use the Plant in the correct manner, only for the purpose for which the Plant was hired and within the parameters for which the Plant has been designed.
- III. AT the Hirers cost ensure the Plant is maintained, safe to use and in good working order, undertake any required repairs and replace any required parts.
- IV. Accept full responsibility for protection of the Plant, it is the Hirers responsibility for the security and protection of the Plant until the Plant is collected by or returned to Interactive whatever the time frame.
- V. The Hirer is liable for the costs of repairing or replacing any damaged and/or stolen leads, plugs, outlets and all other components of the Plant while on hire or until the Plant is collected by or returned to Interactive.
- VI. Accept full responsibility for and indemnify Interactive against all claims in respect of injury to persons, or damage to property arising from the use of the Plant during the hire period or until the Plant is collected or returned to Interactive.
- VII. Are not entitled to place a claim over the Plant, nor without Interactive’s prior written consent part with possession of the Plant or assign the benefit of the hire agreement nor remove the Plant or allow it to be removed from the State.
- VIII. Make any alterations, additions, reductions or deface the Plant or in any other manner interfere or change the Plant.
- IX. Pay to Interactive upon request or as agreed all hire & related charges or other agreed costs.

4. Payment

- I. The payment terms are 14 days from the invoice date unless an alternative payment agreement has been made.
- II. Invoices will be issued within five days of the Plant hire commencement date
- III. Payment made be made by Electronic Funds Transfer.
- IV. Hire transfer cannot be made to a third party unless written approval has been received by Interactive and a new hire application form has been completed. Payment for any hire of Plant is solely the responsibility of the Hirer.
- V. Late payment will incur a fee of \$35 per month for every month the payment is late.

5. Termination of Hire Agreement by Interactive

The agreement can be terminated by Interactive immediately if the Hirer:

- I. Commits an act of bankruptcy
- II. Discontinue Operations or terminate business activities
- III. Breach any terms of this agreement
- IV. Face a liquidation petition or be liquidated
- V. Enter receivership or have its assets placed under receivership

Upon termination of this hire agreement for any reason Interactive shall be entitled to take possession of the Plant. The Hirer will permit Interactive to enter any land or premises on which the Plant is situated.
